AUTHOR INSTRUCTIONS

The Journal publishes articles (which may be experimental or theoretical) broadly concerned with the relationship of physics to the radiation protection.

GENERAL SUBMISSION GUIDELINES

The content of manuscript should not be published previously nor submitted concurrently for the publication elsewhere. Submissions may be in the form of a (1) Original paper, (2) Technical paper, (3) Technical note, and (4) Letter to the editor.

- An Original paper is a report of original experimental or theoretical research. Authors should keep in mind that attention to clarity and conciseness facilitates the review process and also the impact of the published article.
- 2) A *Technical paper* is usually a report of an extensive series of measurements, often involving display in the form of tables or graphs, with text describing the conditions and procedures of measurement. The criteria for Technical papers are validity and utility.
- 3) A *Technical note*. This is a concise description of a specific development, procedure or device which should be a solution to a specific problem and have sufficient relevance to be useful to many readers of our journal.
- 4) *Letters to the editor* normally address a scientific point in connection with a previous publication in our journal.

Manuscripts are normally reviewed by the Editorial Committee and by two or more independent referees chosen by the Editorial Committee. It is important for the author to respond to each specific comment or suggestion in an itemized fashion.

Author should pay the publishing fee for the publication of papers with 50 free copies available. Besides the provided copies, the additional expenses are required.

SUBMISSION MODE

Manuscripts should be submitted to the Editorial Committee with 3 copies by mail or e-mail at anytime. A separate letter including article title, author name(s) and institute(s), corresponding author name and address (postal code, address, telephone number, fax number, and e-mail address) and running title should be submitted. Electronic manuscripts should be prepared using the Microsoft Word or Hangul. The online e-mail submission is preferred.

MANUSCRIPT PREPARATION

 Manuscript should be in the order of Title, Author's name and institute, Abstract, Keywords, Text (Introduction, Materials and Methods, Results and Discussion, Conclusion), References, Table and Figure, and Legend for figure.

- 2) Abstract should be one paragraph, with not more than 6 keywords which begin the first word with a capital letter.
- 3) Superscripts indicating the institute of author or the legends of tables are in the order of * (asterisk), † (dagger), ‡ (double dagger), § (section mark), // (parallel), ¶ (paragraph mark), # (number sign). They are put in front of institutes on departments and, in rear of author.
- 4) Every table and figure must have a caption that is complete and intelligible in itself without reference to the text.
- 5) References should be numbered consecutively in the order they are cited in the text. They should then be listed in the same order at the end of the text. When referenced in the text, enclose the citation number in square brackets, for example '[1]'.
- 6) References in the list should be the following format with names and initials of all authors.
